## Inhalte

### **1. /BMBF\*/ Förderung von Projekten der wissenschaftlich-technologischen Zusammenarbeit mit Kolumbien, Frist: 16. September 2002, 1. Stufe**

---

Es handelt sich um eine bilaterale Ausschreibung, bei der die deutsche Seite Kosten/Ausgaben für deutsche Projektbeteiligte fördert und die kolumbianische Seite Wissenschaftlerinnen und Wissenschaftler aus Kolumbien unterstützt. Dies erfordert eine parallele Antragstellung durch die kolumbianischen Projektpartner (siehe Nummer 7).

Die Förderung bezieht sich auf die Mobilität von projektbezogenem Personal (Personalaustausch), die Koordinierung der bilateralen Kooperation und auf die Organisation von Veranstaltungen. Die geplanten Maßnahmen sollen Forschungsvorhaben begleiten, die aus anderen Quellen finanziert werden.

Forschungsarbeiten können daher nur in geringem Umfang über die Förderrichtlinie gefördert werden.

Es werden Projekte aus den folgenden thematischen Schwerpunktbereichen gefördert:

- Biotechnologie
- Biodiversität
- Gesundheitsforschung
- Meeresforschung
- Geowissenschaften

Antragsberechtigt sind Hochschulen, außeruniversitäre Forschungseinrichtungen und andere Institutionen, die Forschungsbeiträge liefern, sowie Unternehmen der gewerblichen Wirtschaft - insbesondere KMU. Zum Zeitpunkt der Auszahlung einer gewährten Zuwendung wird das Vorhandensein einer Betriebsstätte oder Niederlassung -(Unternehmen) beziehungsweise einer sonstigen Einrichtung, die der nichtwirtschaftlichen Tätigkeit des Zuwendungsempfängers dient (Hochschule, außeruniversitäre Forschungseinrichtung und andere Institutionen, die Forschungsbeiträge liefern), in Deutschland verlangt. Das Antragsverfahren ist zweistufig angelegt.

### **2. /BMEL/ ICT-AGRI-FOOD's 2022, deadline: 15. August 2022 13:00 CEST**

---

The scope of the 2022 Joint Call is based on the ICT-AGRI-FOOD vision, which explicitly sets out to bring together actors from across the entire food system (from conventional and organic supply chains) in a multi-actor approach. The challenge is to develop systems that are efficient, effective, equitable, trustable and transparent while enhancing sustainability of these.

Proposals should address one of the the following topic (s):

TOPIC 1 - Agri-food systems enabled by interconnected digital technologies that are more transparent to consumers, farmers and other stakeholders along the agri-food value chain

This topic includes data-driven systems enabling and promoting transparency for the various end- users along the agri-food value chain from producer to consumer, as well as for advisors, administrative authorities and the policy level (including improved data infrastructure, data management, data governance, data security and protection).

Projects investigate, develop, test, and use digital tools to fill information/communication gaps in the agri-food system along the food value chain. In doing so, the RDI process should start with mapping the value chain from producer to consumer, and in a next step identify and introduce critical points/process

steps where information flow (and transparency) can be improved, and in a further step possible intervention tools could be proposed, integrated and tested. A focus should be on the state of the art and missing technology solutions or the combination of digital tools and methodological gaps. Digital tools that are interconnected should be promoted. The potential transferability of developed solutions to other agri-food systems should be critically addressed.

**TOPIC 2 - Identify, address and remove barriers for adoption of ICT technologies in the agri-food systems**  
This topic relates to identify and address institutional, economic and social barriers on the adoption of ICT technologies for achieving sustainability of the agri-food systems. The following aspects need to be included:

- Integrating social science research to understand social and cultural practices within e.g. farming, food processing, distribution and consumer behaviour aimed to identify mechanisms and models for enhanced adoption of technological solutions and data sharing within agri-food systems.
- Understanding how digitalisation affects structures and behaviour of actors: identifying successful value chains and business models, looking at governance, leadership and organisations within new innovation arenas (e.g. from start-ups to large companies, transition from small to large size with scale-up) of digitalised agri-food systems.
- Identifying solutions to develop more user-friendly technologies and services, such as ethical nudging tools (for e.g. direct marketing and shopping experience), information tools (e.g. social media, apps), gamification approaches, co-design etc.
- Stepping further from barriers identification towards concept solutions, including for example standard development (if applicable).

**TOPIC 3 - Development and impact estimation (if applicable: evaluation) of data-driven reward and incentive systems to support sustainable and resilient farm management practices**

These systems should involve and consider food value chain feedback loops and detecting actors that are willing to bear part of the cost of the engagement for strengthening ecosystem services (including carbon sequestration, biodiversity protection, soil fertility maintenance, protection of water bodies, avoidance of antibiotics, promotion of pollinators etc.). Projects should elaborate targeted advice and digital tools for new policies and regulatory frameworks or other incentive and reward systems.

### **3. /German-Israeli Cooperation/ The Martin Buber Society of Fellows in the Humanities and Social Sciences, deadline: 15. September 2022**

---

The Martin Buber Society of Fellows aims at fostering interdisciplinary academic discourse at the highest level among outstanding young scholars (post-doctoral). Candidates who have completed their PhD at an Israeli or German university, as well as citizens of Israel or Germany who have received their PhD in any country, are eligible to apply. Applicants must have their PhD degree in hand no earlier than October 1st, 2018, and no later than July 1st, 2023.1 Application is open for those specializing in all fields of the Humanities and the Social Sciences.2 We are looking for creative humanists and social scientists with broad intellectual horizons. No connection of the subject matter to Jewish studies or Israel is required. Each year the Academic Committee of the Martin Buber Society of Fellows selects up to ten exceptionally gifted young scholars (up to five from Israel and five from Germany). Fellows receive a monthly stipend of approximately 9000 NIS. They are expected to be in residence and asked to spend at least 4 days a week at the office. The fellows are also encouraged to move to Jerusalem, and those who do receive an additional housing subsidy that can be used either for apartments in the university's Student Village (on campus) or to help with rental costs elsewhere in town. Non-Israeli fellows who move to Jerusalem with their family are eligible for additional support. Fellows have the opportunity to pursue their individual research under optimal conditions for the term of their fellowship and are expected to become part of the vibrant scholarly community in Jerusalem,



reflecting the widest possible disciplinary spectrum in the Humanities and the Social Sciences and embodying a spirit of shared intellectual adventure. They are obliged to participate in biweekly colloquia, workshops, lectures, study excursions, and other cultural and academic activities of the MBSF. Discussions in the Martin Buber Society take place in English (not in Hebrew or German).

Scholarships are granted for a maximum of four years, beginning October 1, 2023 (subject to review at the end of each year), on the basis of a detailed proposal of a research project of major scope and innovative character. Indeed, an imaginative proposal (no longer than 5 pages) that proves the applicant's ability to carry out cutting-edge research in her or his field is the most important part of the application.

#### **4. /German Cancer Aid/ Excellence Funding Programme for Established Scientists, deadline: 22. September 2022, 1. Step**

With the aim of giving well-established, excellent scientists the necessary freedom to develop new conceptual approaches by pursuing innovative, ground-breaking ideas for the prevention, diagnosis and treatment of cancer, the German Cancer Aid has decided to launch a second call for applications within the 'Excellence Funding Programme for Established Scientists'. This programme enables the submission of long-term 'high-risk - high gain' research projects.

Professors and group leaders successfully working in clinical or basic clinically oriented cancer research with an outstanding academic CV are eligible to apply.

The programme gives scientists the opportunity to work on projects that cannot be funded within the scope of other German Cancer Aid funding programmes or by institutional core funding.

Funding of up to a maximum of  $\approx$  1.5 million is available for a period of 5 years.

The procedure for application and evaluation consists of two steps. Project outlines in English must be submitted by 22.09.2022 to the German Cancer Aid. If the preliminary evaluation is favourable, full applications must be submitted by 23.02.2023.

## **9. /European University Institute/ LLM Programme in Comparative, European and International Laws, deadline: 21. January 2023 23:59 CET**

The LLM Programme in Comparative, European and International Laws of the European University Institute (EUI) is a one-year programme. It is predominantly research-based and focusses on the acquisition and practice of research skills and on the preparation of a dissertation. It addresses candidates who wish to advance their legal knowledge and their ability to develop and express scholarly analyses, in a stimulating international and interdisciplinary environment.

The programme is taught by eminent academics, including professors of the EUI, as well as world-renowned guest professors and experts. The programme is attended by an international body of researchers, selected with highly competitive admission criteria.

The Department of Law examines the challenges facing European law, public international law, and private law, looking within cultural, political and economic topics. The range of interests amongst our faculty allows researchers to transcend national boundaries and contexts.

LLM researchers, under the supervision of a Professor in the Department of Law, must obtain a series of necessary credits through term seminars, intensive courses, workshops, and summer schools.

Half of these credits will be obtained by submitting a term paper and a dissertation, which will become the basis for the conferment of the LLM degree.

LLM researchers can attend the cultural and scientific events (lectures, conferences, workshops) that take place at EUI. Each year the Law Department organizes many such initiatives, touching a vast range of subjects concerning European, Comparative and International laws.

Each researcher, with the advice of his/her supervisor, must prepare an individual study programme, choosing among the various term seminars, short seminars, intensive courses, workshops, and summer schools offered by the Department.

Researchers must take at least two regular term seminars in European, International and/or Comparative Laws, one in the first and one in the second term, and attend a seminar in legal research.

Researchers must submit a term paper in preparation for the dissertation (by the end of February), and a completed dissertation (by 1 October of the year following arrival), on the basis of which the LLM will be awarded.

The Max Weber Programme (MWP) at the European University Institute (EUI) is a unique postdoctoral programme in the historical and social sciences in Europe. It is open to applicants who are within 5 years



from the completion of their PhD, from anywhere in the world, regardless of nationality. The Programme is highly selective, with an annual acceptance rate of <5% for a total of 55-60 Fellowships in the fields of political and social sciences, economics, law, and history. Preference is given to applicants who have only just completed their doctorate and have not had a postdoctoral fellowship before. Selected Fellows will benefit from the stimulating combination of a global programme located in the heart of Europe offering a broad menu of multidisciplinary and disciplinary activities.

The Programme awards 1 and 2 year long fellowships according to departments. In extraordinary cases only can a fellowship be extended to a third year.

The grant provided by the Fellowship is currently 2,070 EUR per month plus - when appropriate - a family allowance. Fellows in the Department of Economics and Political and Social Sciences who stay on for a second year will have the possibility of applying for a Part-time assistant professor contract (level ASSPR6/3) for 12 months involving some teaching duties and mentoring Ph.D. researchers: net remuneration would be approximately 850 EUR in addition to the monthly grant. The MWP operates a parental leave policy.

## **18. /Japan Canon Foundation in Europe/ Research Fellowships, deadline: 15. September 2022**

---

Annually, the Canon Foundation in Europe grants up to 15 Fellowships to highly qualified European and Japanese researchers. European Fellows are expected to pursue a period of research in Japan whereas Japanese Fellows are expected to do their research in Europe.

Canon Foundation Fellowships are for a minimum period of three months up to maximum of one year. We support all fields of research. There are no limitations or restrictions. Applicants do not have to be currently enrolled or employed at the time of applying.

Canon Fellows from Europe are free to choose their host institutes and hosts in Japan. The same freedom is given to Japanese Canon Fellows coming to Europe. Canon Foundation Research Fellowships may be applied for when an agreement on co-operation and on a research plan has been reached between the guest researcher and the proposed host institution.

Applications can also be submitted by members of commercial, industrial, governmental or professional organisations.

All Europeans are eligible to apply (including UK, Israel, Turkey, Balkan and Baltic countries).

Applicants should have obtained at least a Master's or PhD degree within the last ten years of applying to the Canon Foundation. We will also consider candidates who obtained their qualification more than ten years ago as long as they provide further supporting information in their application.

The financial support for Research Fellows ranges from 22,500 Euro to 27,500 Euro per year and pro-rata for different periods. The Canon Foundation gives priority to those who plan to travel to Europe or Japan rather than prolong a current stay.

Please note that priority is given to applicants going to Europe and Japan for the first time.

The application deadline will be 15 September, 2022 for applications starting between January and December 2023.
